By signing and returning this confirmation, I agree to participate in the VOICE convention as part of the VOICE On-site Ambassador Support Staff. 

Other conditions of my participation as a VOICE Ambassador are as follows:

1. It is understood that in order to participate as a VOICE Ambassador, I must be a registered conference attendee, stay at the event hotel, and attend the VOICE banquet. This condition applies to all VOICE Ambassadors, including those living locally.
2. I agree to participate in telephone or video conference training calls as may be scheduled prior to the event, and if unable to participate in any live call, I agree to listen to the call recording within a reasonable time.
3. I agree to participate in scheduled training on site prior to the first day of the conference.
4. I understand that assigned Ambassador duties during the conference will be scheduled for a minimum of one 4-hour block. Increased support opportunities may be assigned as each Ambassador is willing to work.
5. I agree to assist with the organizational set-up of the Registration Desk and other duties as may be assigned on the set-up day or at any time during the conference.
6. I understand that my On-site Ambassador duties will be scheduled so as to minimize any disruption of my attendance of convention events, but that some disruption is inevitable.
7. I agree to communicate with the Ambassador Event Manager promptly, to confirm my Ambassador assignments and scheduling details, and to advise of any scheduling conflicts or other issues that may prevent me from participating in mandatory pre-event conference calls or meetings.
8. I understand that I will have access to “behind the scenes” areas and to conference Presenters and dignitaries that may offer opportunities not available to other conference participants. As such, I agree that I will not take undue advantage of these opportunities or make unreasonable requests of those with whom I come in contact.
