Publication Release

COPYRIGHT:

This agreement is not an assignment of copyright, but rather, is a grant and license of specific reuse, reprint, duplication, and distribution rights that pertain to the Work referenced herein.

It is agreed that the Author shall retain copyright to the submitted creative Work content and any graphics or layout design that is part of the original submission, and which may be used by the Publisher as part of the final Publication. The Author further acknowledges and agrees that the submitted Work is their original creation and that any portion of the Work that is not original has been properly credited as to its source.

The Publisher shall retain copyright to the Publication as a whole of which the Work may be a part, and to the layout, graphics, and design of the Work as it appears in the context of the Publication. The Publisher shall, further, not be held responsible or liable in the event that any portion of content submitted by the Author should prove, at any time, to be in violation of International Copyright law.

ASSIGNMENT OF RIGHTS:

It is further agreed that the Publisher shall be granted the following rights in perpetuity, as they apply to the Work, for the purpose of reproducing the Work in print or electronic formats. The specific rights assigned in this agreement are:

- **Reproduction:** Author grants Publisher the right to reproduce the Work in the initial Publication and in subsequent reprinted editions of the Publication, or as part of a different publication, in whatever media and format(s) the Publisher may deem appropriate. Should the Author's work be selected for inclusion in a future edition of "The Art of Voice Acting," a separate Publication release shall apply.
- **Editorial:** Author grants Publisher the right to edit the submitted Work as may be necessary to adjust for space considerations within the Publication. Author further grants Publisher the right to modify the Work in terms of adding supporting graphics, images, and other design elements, which at the discretion of the Publisher may be deemed necessary to prepare the Work for inclusion in the Publication.
- **Distribution:** Author grants publisher the right to distribute the Work within the context of the original Publication in any manner, including print or electronic versions and in any subsequent manner deemed appropriate by the Publisher without notice to the Author.
- **Reuse/Reprint:** Author grants Publisher the right to reuse the Work without additional notice, either as a reprint of the initial Publication, part of a subsequent publication, as a stand-alone publication, or as part of a different Work with a different content layout. Such Reuse and reprint rights shall include, but not be limited to, distribution or sale in any print or electronic format now known or that may be devised in the future. Publisher agrees to include the Author's name and copyright notice in any reuse of said Work.
- **No Royalty:** Author acknowledges that his/her Work is contributed with no expectation of monetary compensation and that the Publication containing the Work may be sold for profit or distributed in other ways and that the Author shall not, at any time, be entitled to any portion of proceeds derived from sales or distribution of the Publication or any derivative works.

AUTHOR RETAINED RIGHTS:

In return for non-exclusive assignment of the above rights, the Author shall receive the following:

- The Author shall retain copyright of the original Work as stipulated above.
- The Author shall retain the right to use, publish in the future, post on the Internet, or sell copies of their original creative work as originally submitted for the Publication or in any other manner.
- Upon request, the Author shall receive an electronic file (PDF or other suitable format) of their Work as designed for inclusion in the Publication. In the event that the Publication includes an edited version of the original submission, or that additional graphics or designs are created by the Publisher for the Publication, the Author may use, print, duplicate, or sell this electronic file in any format for promotional purposes

or use it in electronic or printed form as a supplement to their workshops, classes, etc.

- The Author shall receive a copy of the Publication containing their Work.

The above shall constitute the complete and entire agreement between Author and Publisher.
